6) To update the committee about the passing of KMA Constitution, at a SGM (Special General Meeting) held on 26-03-2025

It was informed that the proposed KMA Constitution was passed during the Special General Meeting held on 26th March 2025. The compilation of all related documents and their submission to the Charity Commissioner will take some time. However, the association will begin functioning as per the newly amended constitution with immediate effect.

Dr. Hema Dave expressed concern, stating that the association should wait until the submission is officially accepted by the Charity Commissioner. She cautioned that if the Charity Commissioner does not accept all the proposed changes, it could pose a problem in the future.

In response, Dr. Vipul Vakil clarified that the Charity Commissioner does not raise objections in such cases, as the association is merely informing the authority of the new constitution. He further added that, as per the legal opinion provided by Advocate Ganesh, once the constitution is passed in the SGM, it can be implemented, and elections can be conducted accordingly.
